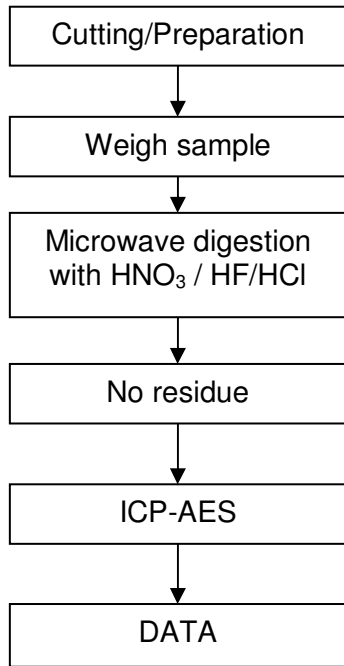

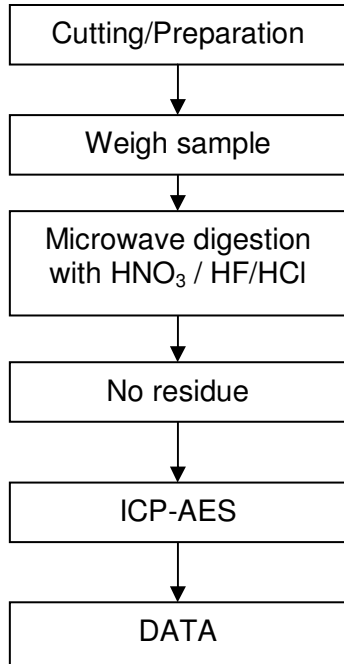


The samples were dissolved totally by pre-conditioning method according to above flow chart.

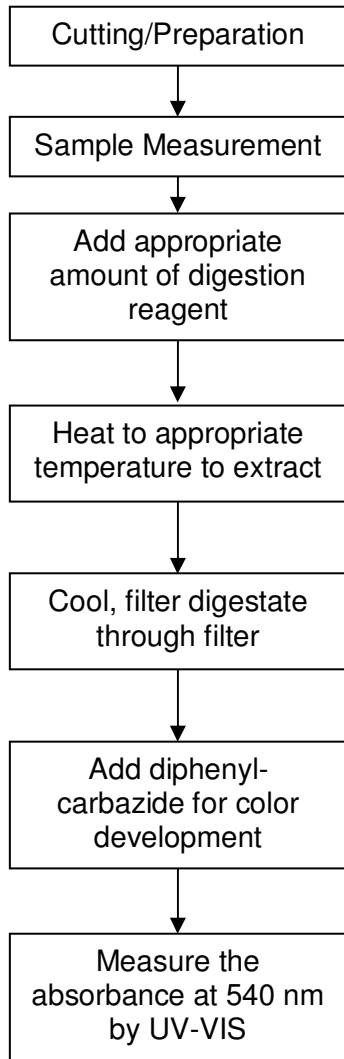
Hg Measurement Flowchart for sample

CrVI Measurement Flowchart for sample

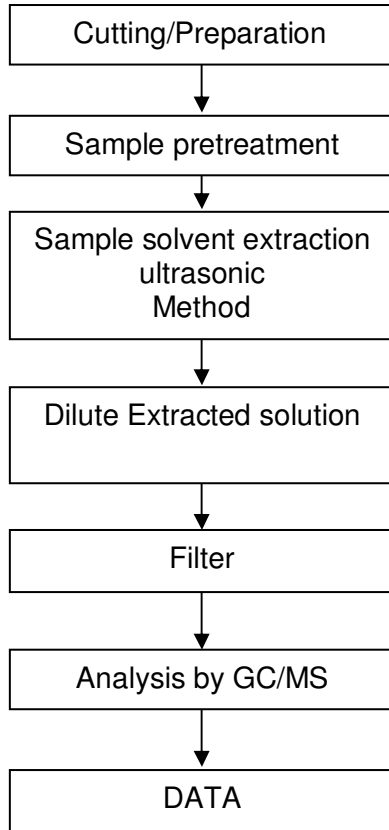

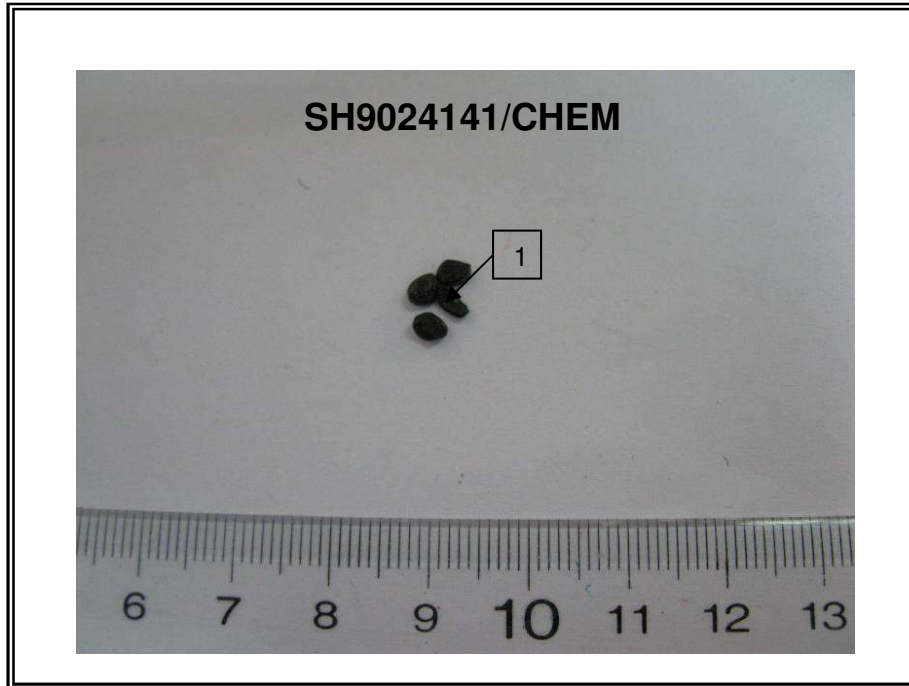
PBBs/PBDEs Measurement Flowchart for sample



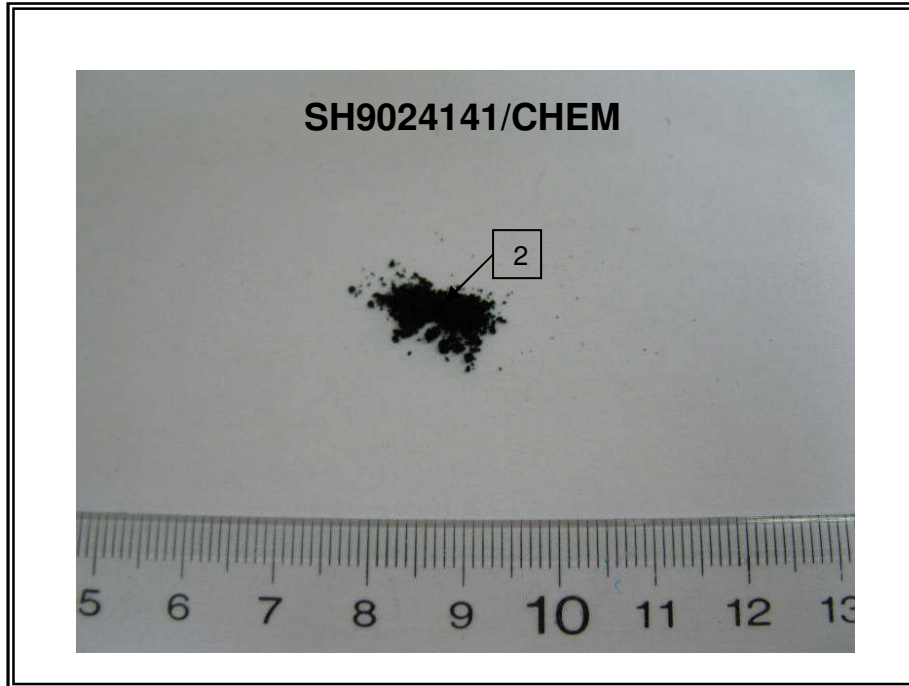
